Dr. Vasiliades possesses over twenty-two (22) years of practical toxicology and clinical chemistry experience, and has testified or provided litigation support in over 1,000 legal cases. Dr. Vasiliades is a Diplomat of the American Board of Forensic Toxicology (DABFT) (1993) and a Diplomat of the American Board of Clinical Chemistry (DABCC) (1980).
